



# LIMITED WARRANTY

This **Limited Warranty** is provided by **Ouellet Canada Inc.** ("Ouellet") to the original end-user ("Purchaser") of a Ductless single zone or multizone Heat Pump ("Product"). This warranty is not assignable or transferable to any subsequent purchaser or user.

The Product must be installed by a certified Ouellet installer and registered within 30 days of installation to be covered by this warranty.\*

The value of this warranty is limited to the original installation value on presentation of the original purchase receipt. If no receipt can be provided, the value of a basic installation sale price will be set at \$3,500.00 as the maximum claim value for the full duration of the warranty.

\*Residents of Quebec are not required to register the Product in order to obtain all of the rights and remedies applicable to this Basic Limited Warranty. The invoice or proof of purchase will be requested when submitting the claim.

## **Basic Limited Warranty Coverage (Applies to parts only and does not cover labour)**

Ouellet warrants that the Product will be free of defects in materials or workmanship under normal use. For a period of 10 years according to the Product series purchased, beginning on the date of installation, verified by an installer's invoice and proof of purchase, Ouellet will supply, at its option, either new or rebuilt replacement parts. Parts covered by this warranty are defined in the "Covered and Not Covered Repairs Guidelines". Ouellet will, at its option, repair or replace the Product.

## **10-year labour warranty (Applies to parts and labour)**

The Basic Limited Warranty covering parts may be improved to include labour for a period of ten (10) years according to the Product series purchased. The Ten-Year Labour warranty must be registered and paid within 30 days from the date of installation at: [www.ouellet.com](http://www.ouellet.com).

(Together hereinafter the "Limited Warrantie")

## **Limited warrantie exclusions and limitations**

- a) Any Product purchased from a non-certified retailer.
- b) Product not installed, serviced, maintained or operated in accordance with Owner's manual.
- c) Any Product not installed by a certified installer.
- d) Product not installed or serviced in accordance with local law, applicable building codes and permits.
- e) Installation, set-up, or adjustment of user controls.
- f) Products that have had a serial number or any part thereof altered, defaced, or removed.
- g) Failure of Product to perform during power failures and interruptions, or incorrect/inadequate electrical service.
- h) Damage and/or failure caused by misuse, neglect, improper adjustment of user controls, modification and/or alteration of the Product or any component thereof, improper sizing or design, or incorporation with other products.
- i) Non-compliant replacement of fuses or replacement or resetting of circuit breakers.
- j) Damage due to the use of unapproved refrigerant types or use of recycled refrigerant.
- k) The warranty is not transferable when there is a change of owner at the residence where the product is installed.
